THE CORALWOOD SCHOOL

Coralwood School is the only public school in DeKalb County, Georgia dedicated to serving children with special needs between three to six years of age. Our research-based educational model includes 12 collaborative and co-teaching classrooms in which six to eight children with special needs and ten typically developing children are educated together. Research shows that this model results in significant gains for special education students, including higher levels of social play, more appropriate social interactions and greater gains in language, cognitive and motor development. Additionally, Coralwood has four self-contained classrooms that serve children with more severe disabilities. Children in the self-contained classes engage in multiple learning experiences with typically developing children throughout the school day.

The classrooms at Coralwood are led by highly specialized teachers and paraprofessionals who cater to a broad set of students with varied needs. The teachers work closely with the following therapists: speech/language, occupational, physical, vision and recreational. Primarily, these therapists provide services to children in the classroom and include both special needs and typical children in various therapies.

WHAT IS THE CORALWOOD FOUNDATION?



Coralwood Foundation was incorporated in May 2005 to create a permanent endowment fund, the interest income of which is used to promote excellence in early childhood special education at Coralwood, and to provide a vehicle for long-term financial and volunteer support for Coralwood. The Foundation funds the educational innovations of teachers and other professionals at Coralwood and funds a Director of Development, who writes grants and raises funds for specific educational initiatives.

Currently, the efforts of the Foundation's Board of Directors are focused on the following initiatives:

- Providing learning opportunities, grants for classroom initiatives and professional development for our school staff;
- Supporting the financial goals of the Foundation through fundraisers such as our Silent Auction and Wine Tasting Dinner, as well as grant writing activities;
- Working with county-funded architects to implement the Master Plan for Coralwood's campus in order to provide enhanced educational opportunities for our children;
- Building the Tree House on the Nature Trail;
- Developing a marketing and communications plan that will position Coralwood School as the premier inclusion preschool in Georgia;
- Redesigning the website to provide a central location for comprehensive information about Coralwood, the Foundation and parent resources;
- Researching theme school and charter school options;
- Actively engaging Coralwood alumni, parents and friends in the continued work of the Foundation through community involvement and outreach as part of the newly formed "Coralwood Circle of Friends" group.

The Foundation views these projects as fundamental elements to improve the education of our children now and in the future.

MESSAGE FROM THE PRESIDENT

When my daughter started in the three year old program at Coralwood in 2003, Coralwood was short on funding, volunteers and optimism.

- The principal received only \$4,000 to meet all financial needs of the school, except for building costs and salaries.
- The building had broken light fixtures, peeling paint and a dingy and uninviting cafeteria.
- Classrooms were cramped, shabby and poorly equipped.
- Our teachers paid for most of their classroom needs out of their pockets and did not receive funding for professional development or continuing education.
- The stage was divided into cubicles as office space for staff.
- The playground was a mud hole with tree stumps, a rusty wheelchair swing, and plastic playground equipment that was not handicap-accessible.
- The front of the school was a gravel parking lot with no landscaping or signage.

I was heartsick--was this the best educational experience that I could offer to my special needs child?



Since formation in 2005, the Foundation has raised \$300,000 in its annual Classroom Challenge campaigns for the Endowment Fund and capital improvements with 100% parent participation in 2008-2009. The funds from the Classroom Challenge are used to benefit our current students by funding immediate classroom needs and by partially funding the salary of the Director of Development. For example, this year, \$9,000 of the \$67,000 contributed to the Classroom Challenge immediately went to classroom teachers and paid for literacy and numeracy instructional materials. The remaining \$58,000 from the Classroom Challenge went straight to the Endowment Fund, the earnings from which help pay for the salary of our Director of Development, Jennifer Sedlack who:

- Meets with teachers to determine their needs and helps develop their ideas for classroom innovations;
- · Writes grants to secure funding for the teachers and helps them carry out the program goals; and
- · Coordinates fundraising activities and serves as the Foundation's daily presence at Coralwood.

Jennifer is committed to making the teachers' dreams a reality for our children who are learning through art, music, technology and campus improvements. Jennifer has helped us raise \$315,000 through special events, grants and in-kind donations. Check out the list on page five of the grants received this year. You will be so impressed!

Additionally, when we give to the Classroom Challenge, we also show our commitment to children who will be Coralwood students in the future. This vision was embraced by the donors in the 2006-2007 Classroom Challenge who gave \$75,000 for capital improvements as part of the Foundation's Master Plan. These contributions are funding the Nature Trail, the Tree House, Promethean ActivBoards in the classrooms and media center, and other capital needs. The generosity of those parents and supporters in 2006 directly benefits our children today, just as your donations to the 2008-2009 Classroom Challenge will benefit current and future Coralwood children.

The commitment of the Coralwood community makes the vision of a model education for young children in an inclusive setting a reality. With every dollar raised at the Silent Auction, Wine Tasting, and the Classroom Challenge, we are able to reinvest those resources in our teachers and classrooms, either directly or through the efforts of our Director of Development. I want to express my deepest thanks for the generous donations and countless hours of service by our directors, staff, parents and our many volunteers. Your children receive a richer education because of our community's commitment to the vision of academic excellence at the Coralwood School.

MESSAGE FROM THE PRINCIPAL



Coralwood School has risen to national prominence in the past four years due in large part to the Coralwood Foundation's vision of achieving excellence in early childhood special education.

- Coralwood School will be featured in an upcoming issue of *Impact*, a publication by the College of Education and Human Development, University of Minnesota.
- Coralwood was featured in the PBS Reading Rockets literacy series.
- · School systems across the southeast continue to visit and observe our preschool inclusion model.
- Coralwood has received the Governor's Platinum Award from the Office of School Achievement for the past four years.

Since its formation in 2005, the Foundation's vision and financial support have greatly benefited Coralwood students and staff. The Foundation is in the forefront in demonstrating how a dedicated Board of Directors lends support in the areas of professional development, grants, classroom materials and supplies, volunteerism and campus improvements.

Teachers and therapists attend trainings that directly impact instruction in their classrooms and the lives of young students. The Foundation has made it possible for staff to attend the following: Orton-Gillingham training, a multi-sensory approach to reading; Handwriting without Tears; Floortime; Applied Behavioral Anaylsis; Creating Pride, a workshop for integrating arts into the curriculum; Affect Based Language Curriculum; and Celebrating Calm, a workshop on research-based interventions for the classroom.

Community volunteers met for a year to design and develop a Master Plan during the 2007-2008 school year. In May 2009, the ADA accessible Nature Trail became a reality as the result of the Foundation's Master Plan Committee. Currently, architectural plans are being developed to renovate and add much needed therapy space to the building along with six additional classrooms. Join the "Coralwood Circle of Friends" and watch us grow.

Coralwood School has made incredible strides on our journey toward academic excellence through the successes of the Foundation's Director of Development, Jennifer Sedlack. This year alone, her impact is evident in the new ActivBoard and laptop in Joy Hurd's classroom; in the kindergarten Dance Curriculum under development; in the Fall Festival she created and secured funding for; in the ADA-accessible Nature Trail which includes exercise equipment, an Outdoor Classroom and a planned Tree House; in the Teacher Mini-Grants program she developed and administers each year; and in encouraging our teachers to create innovative learning environments to help every child succeed. All Coralwood students benefit from this amazing work and support.

FISCAL YEAR 2009 PROGRESS REPORT

During Fiscal Year 2009, the Coralwood Foundation successfully accomplished the following objectives:

- Raised \$67,000 toward the Endowment Fund through the Classroom Challenge;
- Achieved 100% parent participation in the Classroom Challenge from Coralwood families;
- Awarded \$8,900 for academic support to the 18 classes with 100% participation in the Classroom Challenge;
- Raised nearly \$28,000 through the Silent Auction and Wine Tasting;
- Built the ADA handicapped accessible Nature Trail portion of the Master Plan;
- Designed an ADA handicapped accessible Tree House for the Nature Trail;
- Successfully lobbied the DeKalb County School System to hire architects to begin drawing plans for the school expansion portion of the Coralwood Master Plan;
- Advocated to promote Coralwood's inclusion program and to preserve our partnership with Hawthorne Elementary;
- Received six grants totaling \$41,000 for a Promethean ActivBoard, laptops, development of a kindergarten arts curriculum, additional music classes, a free family festival, cultural arts programs, health and nutrition programing, the Nature Trail and related fitness equipment, and funds toward a Tree House along the Nature Trail;
- Presented five teachers with a total of \$1,400 in Mini-Grants for Teachers awards which funded a recycling program, an advanced reader group, yoga instruction to help modify behavior, a dramatic play program and Twin Vision books which allow sighted and blind students to read together;
- Awarded \$7,200 to teachers and staff to participate in both in-house professional development and off-site conferences through the
 Higher Opportunities for Teachers committee. Teachers were trained in Handwriting without Tears, Orton-Gillingham's multi-sensory
 approach to reading, and other innovative teaching methods.
